A 45 year veteran of the Fanwood Volunteer Fire Department, Jack has dealt with his share of dangerous situations. But none equaled the one he faced early on the morning of December 17,

A Message from Mayor Jung

After a shutdown for the winter, the downtown streetscaping is underway again. As I write this, PSE&G has begun installing the Victorian Bishop's Crook and Scroll street lamps after pulling the electrical wiring through the underground conduits that were installed last fall along with the new concrete sidewalks and pavers. Viola Construction will return this Spring to complete its contract - installing the streetscaping behind the stores on the West side of South Martine Avenue and on South Avenue between Second Street and Sheelen's Crossing and in front of the Chelsea. This is being funded with grants from the Union County Freeholders (\$300K) and the State Legislature (\$100K).

As of this writing, the contract with NJ Transit (NJT) for the new and expanded parking lot for the South side of the train station is being finalized and scheduled for Mayor and Council approval on March 15th. NJT is now scheduled to begin the project in early summer. The project includes clearing the cur-

Once they got a pulse, Jack was rushed to the hospital. He returned home the day after Christmas with his new best friend-an implanted pacemaker/defibrillator. Portable automated external defibrillators (AED's) are standard equipment on the ambulances and will soon be standard equipment on Fanwood's police cars and fire engines. PEDESTRIAN SAFETY TIPS

When crossing at signalized intersections, utilize the pedestrian crosswalk button. This button does not change the traffic signal but extends the time for the pedestrian to cross the street.

DRIVER SAFETY TIPS

- Look before making a right turn at a red light, if allowed. Make sure to look to the right, as well as to the left, so as not to miss a crossing pedestrian.
- Be especially attentive to pedestrians walking along the roadway when operating a radio or cell phone.
- Watch for pedestrians who are walking with traffic rather than against traffic.
- Be aware that pedestrians may have more difficulty seeing vehicles in rainy conditions, especially if items such as umbrellas block their vision.
- Also, be aware of the extra time and distance it will take your vehicle to stop in inclement weather.
- Be vigilant in areas where children may dart out unexpectedly into traffic. These areas include residential and school areas, near school busses, park areas, and around frozen dessert trucks.

To help underwrite the estimated cost of this size tree - approximately \$1,500 and to stretch the grant money a little further, residents will be welcome to purchase "a piece" of the new Fanwood Oak.

A \$10 share entitles you very near future.

Fanwood Oak. All shareholders will receive a certificate of ownership and be recorded by resolution in the minutes of a Fanwood Borough Council meeting. We hope to celebrate Arbor Day with our new tree at home in our new park.

For the past year, I have served as chairman of the Council Finance and Administration Committee along with Council President Joel Whitaker and Councilwoman Katherine Mitchell.

Every month, the Committee meets with Borough Administrator Eleanor McGovern and Chief Financial Officer Barbara Brennan to discuss a variety of issues which directly impact how we spend the Borough's money.

Over the last few months. for instance, the Committee has evaluated several issues including whether to accept credit cards to pay for borough services (e.g. for construction fees, dog licenses, or municipal court fines), the Comprehensive Enforcement Program (a State agency which targets collection of delinquent municipal court fines), implementation of an employee assistance program, and direct deposit of employee paychecks.

We also have addressed various aspects of Borough administration, such as or-

One of the most important issues the Committee is looking at is the cost of health care insurance benefits for borough employees.

Last year, based upon the Committee's recommendation, the Borough appointed Commerce National as the new health insurance broker to help contain the ever increasing costs.

The Committee will continue its efforts throughout the year to provide quality health care benefits to Borough employees that are also affordable for our residents.

From healthcare benefits to where the Borough banks, the Administration and Finance Committee will keep recommending ways to keep costs, and thus taxes, as low as possible.

Lifepak 500 defibrillators are being purchased. Each of the Rescue Squad's two ambulances will get one to replace the older First Medic models now in use. Each police patrol car and each fire engine will also be equipped. The police department is hoping to get a seventh AED donated to keep in police headquarters. The Lifepak 500, manufactured by Medtronic Physio-Control, costs about \$3,000. AED's have gotten so simple to operate that even lay persons can be quickly and easily trained to operate them. They have only two or three buttons and a computerized voice actually talks you through the process. The Fanwood Rescue Squad's members are certified in their use, and training will be provided for police and fire personnel.

Important Safety Tips for Pedestrian and Motorist

Spring is just around the corner. A time of year where everyone emerges from their homes and many enjoy a leisurely stroll. The Fanwood police department would like to offer the following tips to pedestrians and motorists to help everyone have a safe and enjoyable Springtime:

PEDESTRIAN SAFETY TIPS

- Do not jaywalk. Always try to cross the street at a crosswalk or signalized intersection.
- Do not assume that a green light, a walk signal, or a crosswalk means the street is safe to cross. Look left, right, then left again before crossing. Be aware that some drivers may disregard traffic rules and that you must be aware of vehicles even when you have the right of way.
- Carry a flashlight when walking at night and wear reflective materials so drivers can easily spot you.
- Walk on sidewalks whenever they are available. When they are not, walk facing traffic as far off the roadway as possible.
- Be aware of limited visibility and the extra time and distance it takes vehicles to stop in rainy conditions.
- Refrain from using cell phones and headsets while walking along a roadway. Your attention and hearing are greatly diminished. - continued on page 2

DRIVER SAFETY TIPS

- Yield to pedestrians. Do not attempt to pass in front of or around pedestrians while they are in crosswalks.
- Obey the posted speed limit. The risk of injury to a pedestrian increases with the speed of the vehicle.
- Do not pass cars stopped at an intersection as these cars may be stopped for pedestrians. Pedestrians may get caught in an intersection when the light changes.
- Stop well short of the crosswalk at an intersection so as not to block pedestrian crossing signals.
