# **Ordinance 17-01-R**

Huegel/Mitchell moved to open the Public Hearing on Ordinance 17-01-R. Motion carried. No one spoke.

Huegel/Mitchell moved to adopt Ordinance 17-01-R on second reading. Motion carried on the following roll call vote.

# AN ORDINANCE OF THE BOROUGH OF FANWOOD, COUNTY OF UNION, AND STATE OF NEW JERSEY, AMENDING THE EXEMPTION AND ABATEMENT FOR COMMERCIAL AND INDUSTRIAL STRUCTURES IN REHABILITATION AREA

WHEREAS, pursuant to the Five Year Exemption and Abatement Law, N.J.S.A. 40A:21-1 et seq., a municipality having within its corporate limits areas in need of rehabilitation or redevelopment may, by ordinance, provide for the exemption and/or abatement of real property taxes, to encourage and provide incentives for the construction, redevelopment and rehabilitation of industrial and commercial structures; and

**WHEREAS**, the Borough Council (the "Council") of the Borough of Fanwood (the "Borough") previously designated certain real properties along South Avenue identified as Block 55, Lots 5.01, 7.01, 8, 9.01, 10, 11 and 11.01, and Block 57, Lot 1, on the official tax map of the Borough as an area in need of rehabilitation called the "Old South Avenue Rehabilitation Area" in accordance with the provisions of the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. ("LRHL"); and

WHEREAS, pursuant to N.J.S.A. 40A:21-1 et seq. the Borough of Fanwood passed an ordinance which provides for assessments for five years following completion of a project as defined in the statute and the exemption or abatement of property taxes for new construction for a five-year period following completion of the project as defined in the statute.

**WHEREAS**, in accordance with <u>N.J.S.A.</u> 40A:12A-14, the Mayor and Council designated additional real properties along South Avenue identified on Exhibit "A" attached to the Resolution No. 16-09-143 as an area in need of rehabilitation and added to and incorporated the additional properties within the Old South Avenue Rehabilitation Area; and

**WHEREAS**, the Borough desires to extend the real estate tax incentives to these additional commercial and industrial structures within the Old South Avenue Rehabilitation Area; and

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Fanwood, County of Union, State of New Jersey, as follows:

Section 1. That Chapter 268 Taxation, Article 1, Exemption and Abatement for Commercial and Industrial Structures in Rehabilitation Area, Section 268-4 Rehabilitation Area, be and is hereby amended by deleting and replacing with the following:

# 4. Rehabilitation Area.

All commercial and industrial structures located within the following defined area in need of rehabilitation shall be eligible for tax abatement under this chapter:

Tax Block 55, Lots 1, 2, 4, 5.01, 7.01, 8, 9.01, 10, 11, 11.01, 12, 13, 14, 15, 15.01, 16, 17, 18, 19

Block 56, Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10

Block No. 57, Lot No. 1

Block 60, Lot 1, 2, 3, 4

Block 61, Lots 2.01, 2.02, 3, 4

Block 62, Lot 2

Block 65, Lots 1, 2, 3, 11, 12, 14

Block 66, Lots 1, 2, 3, 6, 9, 10, 11, 14

Block 69, Lots 1, 5, 6

Block 91, Lots 1.01, 3.01, 6, 26

Section 2. All other provisions of Chapter 268 shall remain in full force and effect.

Section 3. If any part(s) of this Ordinance shall be deemed invalid, such part(s) shall be severed and the invalidity thereof shall not affect the remaining parts of this Ordinance.

Section 4. This Ordinance shall take effect as provided by law.
