Mr. Foerst outlined the concessions his applicant has made to date and went on to offer a fence height reduction on the rear property line to 4 feet, which will result in a fence height of 7 foot 6 inches at its apex, ranging down as low as 5-foot 5-inches.

The applicant commits to removing the encroachment on the rear neighbor, and will secure a structural certificate to guarantee its soundness.

Applicant will enter into an agreement to maintain the retaining wall that they built in the right-of-way.

Applicant commits to beautifying the wall facing the rear neighbor for aesthetics. Applicant refuses to plant/maintain trees on the property of the rear neighbor.

Meeting was opened to the public and the rear neighbor, Vanessa Hobbs, testified that despite the instructions given at the November 29 meeting, the applicant had never reached out to discuss a settlement. Ms. Hobbs contacted the contractor and there was a discussion of beautifying the wall. Ms. Hobbs request for tree plantings and maintenance were rejected.
