employee intends to use as vacation time for the current calendar year. Every effort will be made to grant your request for vacation at the time you desire. If any conflicts arise in requests for vacation, preference will be given based on seniority. The Borough Clerk shall respond, in writing, to the employee submitting vacation time by January 31 of the current calendar year. Department Heads shall submit their vacation day request to the appropriate Council Liaison no less than thirty (30) days from the time that the individual intends to use that vacation time.

PERSONAL DAYS

Full time employees will be eligible to receive three (3) personal days per year. Non-Contractual employees shall notify the Administrator or Deputy Administrator of their intention to use a personal day as soon as practicable.

HOLIDAYS

The Borough provides paid time off to all Full-Time Regular Employees for the following fifteen (15) holidays per calendar year:

All national holidays are scheduled on the day designated by common business practice. Holidays falling on a Saturday are normally observed on the preceding Friday. Holidays falling on a Sunday are normally observed on the following Monday. You will be notified prior to the beginning of each calendar year of the actual dates on which each of these holidays is observed.

In order to be eligible to receive holiday pay, eligible employees must work the scheduled workday immediately before and after the holiday or be on an approved vacation during the holiday. Only excused absences will be considered exceptions to this policy.

Religious Holidays

If you wish to take time off to observe a religious holiday, you may substitute an unused vacation or personal day. If no vacation or personal days are available, employees will be granted unpaid time off to observe religious holidays. Employees are required to schedule the time off in advance with your supervisor. Non-Contractual employees shall notify the Administrator or Deputy Administrator of their intention to use a personal day as soon as practicable.
