ORDINANCE AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION IN THE AMOUNT OF \$110,000 OR SUCH OTHER AMOUNT CERTIFIED BY THE DIRECTOR OF THE DIVISION OF LOCAL GOVERNMENT SERVICES, FOR THE PURPOSES SET FORTH IN N.J.S.A. 40a:4-53(M), IN AND BY THE BOROUGH OF FANWOOD, COUNTY OF UNION, NEW JERSEY

# BE IT ORDAINED BY THE COUNCIL OF THE BOROUGH OF FANWOOD, IN THE COUNTY OF UNION, NEW JERSEY AS FOLLOWS:

Section 1. The Borough of Fanwood, in the County of Union, New Jersey (the "Borough") hereby appropriates an aggregate the amount of \$110,000 to provide for such time as a public health emergency, pursuant to the "Emergency Health Powers Act" P.L.2005, c222 (C.26:13-1 et seq.), declared in response to COVID-19 remains in effect, a deficit in operations experienced by the Borough during fiscal year 2020, in which a public health emergency pursuant to the "Emergency Health Powers Act," P.L. 2005, c.222 (C.26:13-1 et seq.), or a state of emergency, pursuant to P.L. 1942, c.251 (C.App.A:9-33 et seq), or both has been declared by the Governor in response to COVID-19, in the amount of \$110,000 pursuant to N.J.S.A. 40A:4-53(m). The appropriation authorized hereby shall be in the amounts set forth herein or such other amounts as certified by the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey (the "Director").

**Section 2.** The Borough shall apply for any financial assistance that may be available to the Borough from the federal government, the State of New Jersey, and other sources to offset any operating deficit directly attributable to COVID-19, and any such financial assistance obtained by the Borough shall be utilized to offset any operating deficit.

Section 3. A copy of this Ordinance as finally adopted shall be filed with the Director.

**Section 4.** This ordinance shall take effect upon the latter of (i) the date determined by applicable law or (ii) the earlier of (a) the date the Director approves in writing the application submitted by the Chief Financial Officer of the Borough for approval of the special emergency authorized hereby (the "Application") and (b) the date that is 45 days (or the first business day following such 45<sup>th</sup> day, if applicable) following the date the Chief Financial Officer submit the Application to the Director.

ORDINANCE OF THE BOROUGH OF FANWOOD, COUNTY OF UNION, NEW JERSEY VACATING PROTIONS OF THE PUBLIC ROADS KNOWN AS OLD SOUTH AVENUE

WHEREAS, pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. (the "Redevelopment Law") On October 15, 2018, the Fanwood Borough Council found that the subject property, Old South Avenue Corridor, in the Borough of Fanwood, County of Union and State of New Jersey, known and designated as Block 55, Lots 7.01, 8, 9.0101, 9.0102, 10, 11, 11.01, 12 and Block 57, Lot 1, inclusive of any and all streets, and right of ways, as shown on the official Tax Map of the Borough of Fanwood, met the criteria set forth in N.J.S.A. 40A:12A-5(c) and (e) for redevelopment designation and that the delineated area be designated as an area in need of redevelopment, as a non-condemnation redevelopment area, in accordance with N.J.S.A. 40A:12A-1, et seq. to be known as "Old South Avenue Redevelopment Area"; and

**WHEREAS**, pursuant to the Redevelopment Law, the Borough Council caused a redevelopment plan for the Old South Avenue Redevelopment Area to be prepared by Phillips Preiss, Grygiel Leheny Hughes LLC, entitled "Old South Avenue Redevelopment Area" (the "Redevelopment Plan"); and

WHEREAS, the Borough Council on August 5, 2019, following the Planning Board's review and comment upon the Redevelopment Plan, pursuant to the Redevelopment Law, adopted the Redevelopment Plan by Ordinance No. 19-12-R as it was in the best interests of the Borough and the redevelopment of the Redevelopment Area.; and

WHEREAS, Carano Square LLC (the "Redeveloper") is the owner of a property in the Redevelopment Area, the property being known as "A and P property" at 61 and 105 South Avenue, also known as Block 55, Lot 11, 11.01 and 12 and contingent contract purchaser of Block 57, Lot 1; and

WHEREAS, the Redeveloper is proposing the development of mixed-use project including ground floor restaurant space and residential units in multi-story structure on the Property (the "Project") and has submitted a Redevelopment Proposal Application; and

**WHEREAS**, the Borough Council, acting as the Redevelopment Agency, of the Borough of Fanwood approved Resolution No. 20-01-01 conditionally designating Redeveloper for the Old South Avenue Redevelopment Area; and

**WHEREAS**, the Redevelopment Plan provides for the vacation of the Old South Avenue for use in a Redevelopment Project; and

**WHEREAS,** N.J.S.A. 40:11A-23(1)(c), 40A:12A-8f and 40:67-1 et seq. all permit the Borough to close and vacate its interest in streets where necessary for projects such as the Redevelopment Project.

**NOW, THEREFORE, BE IT RESOLVED,** by the Mayor and Council of the Borough of Fanwood, New Jersey as follows:

Section 1. The Borough hereby vacates the portions of Old South Avenue as stated in the meets and bounds attached hereto as follows:

Exhibit A- Description of Existing Right of Way to Remain in Old South Avenue, Block 55.

Exhibit B- Description of Portion of Existing Right of Way to be Vacated located in Proposed Tax Lot 12.02 Block 55.

Exhibit C- Description of Portion of Existing Right of Way to be Vacated located in Proposed Tax Lot 12.01, Block 55.

- Section 2. The Mayor, Borough Administrator, or Borough Chief Financial Officer, are hereby authorized and directed to take such steps and execute such documents as are necessary for the Borough to deed the vacated portions of the streets set forth above to the Redeveloper, the consideration for which shall be One Dollar (\$1.00), in a manner consistent with the provisions of this Ordinance and the Redevelopment Agreement.
- Section 3. The Clerk of the Borough is hereby authorized and directed to: (i) publish notice of the introduction of this Ordinance pursuant to N.J.S.A. 40:49-2; provided, however, that notice as to such introduction and public hearing shall be made, pursuant to N.J.S.A. 40:49-6, at least ten (10) days prior to the public hearing and adoption hereof; and (ii) to mail, at least one week prior to the public hearing and adoption hereof, a copy of the notice referenced in subsection (i) hereof to every person whose lands may be affected by this Ordinance
- Section 4. Within sixty (60) days after adoption of this ordinance, the Borough Clerk is authorized and directed to cause a certified copy of this ordinance to be filed with the office of the Union County Register.

BOND ORDINANCE AMENDING BOND ORDINANCE NUMBER 20-14-S FINALLY ADOPTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF FANWOOD, NEW JERSEY ON SEPTEMBER 21, 2020

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF FANWOOD, IN THE COUNTY OF UNION, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The Bond Ordinance of the Borough Council of the Borough of Fanwood, in the County of Union, New Jersey (the "Borough") entitled "Bond Ordinance Providing An Appropriation Of \$150,000 For Improvements to Forest Road Park in And By The Borough Of Fanwood In The County Of Union, New Jersey And, Authorizing The Issuance Of \$142,500 Bonds Or Notes Of The Borough For Financing Part Of The Appropriation" finally adopted on September 21, 2020 (the "Ordinance") is hereby incorporated by reference in its entirety.

Section 2. (a) Section 1 of the Ordinance is hereby amended in its entirety as follows:

"The improvements described in Section 3 of this bond ordinance (the "Improvements") are hereby authorized to be undertaken by the Borough of Fanwood, New Jersey (the "Borough") as general improvements. For the said Improvements there is hereby appropriated the amount of \$150,000, such sum includes the sum of (a) \$40,000 expected to be received from a Union County Kids Recreation Grant and (b \$7,500 as the down payment (the "Down Payment") required by the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes, as amended and supplemented (the "Local Bond Law"). The Down Payment is now available by virtue of provision in the Open Space, Recreation, Farmland and Historic Preservation Trust Fund."

- (b) The Ordinance is hereby further amended by deleting the reference of \$150,000 for the appropriation and estimated cost and substituting in lieu therefor \$190,000.
- Section 3. The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolutions in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.
- Section 4. This Section 4 constitutes a declaration of official intent under Treasury Regulation Section 1.150-2. The Borough reasonably expects to pay expenditures with respect to the Improvements prior to the date that the Borough incurs debt obligations under this Bond Ordinance. The Borough reasonably expects to reimburse such expenditures with the proceeds of debt to be incurred by the Borough under this Bond Ordinance. The maximum principal amount of debt expected to be issued for payment of the costs of the Improvements is \$142,500.

Section 5. All other provisions of the Ordinance shall remain unchanged.

Section 6. This amendatory bond ordinance shall take effect twenty days after the first publication thereof after final adoption as provided by Local Bond Law.

- Warranties and technical support for the equipment and computer programs 3.

WHEREAS, the Borough wishes to act upon Axon Enterprises, Inc's October 22, 2020 proposal to acquire the necessary hardware, software and technical support to maintain the level of service and performance of its Police Department; and

WHEREAS, the Governor of the State of New Jersey (the "State") has heretofore declared a public health emergency and a state of emergency in response to the outbreak of the coronavirus disease 2019 as announced by the World Health Organization on February 11, 2020, and first identified in Wuhan, China ("COVID-19"); and

WHEREAS, N.J.S.A. 40A:4-53(m) provides that a municipality may, subject to the approval of the Director of the Division of Local Government Services in the New Jersey Department of Community Affairs (the "Director"), adopt an ordinance providing for a special emergency appropriation for the funding of a deficit in operations of the Borough directly attributable to COVID-19; and

WHEREAS, the Chief Financial Officer of the Borough of Fanwood, in the County of Union, New Jersey (the "Borough") has executed a certification in the form prescribed by the Director, a copy of which has been presented to this meeting (the "Certification"), certifying that the deficit balance in the sewer utility fund anticipated to be reported on the Borough's "Results of Operations" schedule of the annual financial statement for the current fiscal year is \$125,000; and

WHEREAS, the Borough has introduced, or expects to introduce, an ordinance authorizing a special emergency appropriation in the amount of \$125,000 to provide for the funding of such anticipated operating deficit balance in the sewer utility fund (the "Ordinance"); and

WHEREAS, the Borough Council of the Borough now wishes to approve the Certification, together with the Borough's application to the Director seeking approval of the adoption of the Ordinance;

### NOW, THEREFORE, BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF FANWOOD, IN THE COUNTY OF UNION, NEW JERSEY as follows:

# GARDEN STATE MUNICIPAL JOINT INSURANCE FUND INDEMNITY AND TRUST AGREEMENT TO REJOIN

WHEREAS, a number of local governmental units in the State of New Jersey have joined together to form a Joint Insurance Fund as permitted by the Chapter 372 Laws of 1983 (40A:10-36); and

WHEREAS, the statutes and regulations governing the creation and operation of a Joint Insurance Fund contain elaborate restrictions and safeguards concerning the safe and efficient administration of the public interest entrusted to such a Fund; and

WHEREAS, the Governing Body of the Borough of Fanwood, has determined that membership in the Garden State Municipal Joint Insurance Fund (hereinafter referred to as the "Fund") is in the best interests of itself and its citizens; and

**WHEREAS**, the Governing Body of the Borough of **Fanwood**, has previously executed a resolution to join the Garden State Municipal Joint Insurance Fund subject to the acceptance of its assessment;

**NOW, THEREFORE, BE IT RESOLVED** that the Governing Body of the Borough of **Fanwood** (hereinafter referred to as the "Municipality") does hereby resolve and agree to renew its membership in the Fund for a period not to exceed three (3) years beginning January 1, 2021 to December 31, 2023 for the purpose of establishing the following types of coverage:

- Workers' Compensation and Employer's Liability;
- General Liability including law enforcement and public official's liability;
- Motor vehicle liability;
- Property damage (buildings, contents, equipment, and motor vehicle);

**BE IT FURTHER RESOLVED,** that the Municipality has never defaulted on claims and has not been canceled for nonpayment of insurance premiums for a period of at least two years prior to the adoption of this Resolution; and

**BE IT FURTHER RESOLVED,** that the Mayor and the Municipal Clerk are authorized and directed to execute the Indemnity and Trust Agreement and such other documents signifying membership in the Fund and to deliver same to the Executive Director of the Fund with the express reservation that said document shall become effective only upon approval by the New Jersey Department of Insurance and the Department of Community Affairs.
